

## Natalie Evans Chosen 2024 IAAF Queen

Natalie represented Morgan County and will represent the IAAF at a series of official functions during the coming year.

The 2024 IAAF convention theme, "Do More in '24" in January at the Crowne Plaza, spurred attendees to action.

From the Trade and Talent shows to the Showcase and queen competition, participants learned what they could do to add extra pizzazz and fun to their fairs this summer – from a scavenger hunt in the Trade Show to a Corn Hole game in the lobby to shooting basketballs, the convention was designed to help those attending take their fairs to the next level.

Natalie Evans of Jacksonville, IL, 19, was crowned 2024 Miss Illinois County Fair Queen.

Natalie represented Morgan County at the 113th Illinois Association of Agricultural Fairs Convention on Sunday, Jan. 14, 2024. Evans is the daughter of Sean and Amy Evans and is currently attending Murray State University majoring in pre-veterinarian with a minor in chemistry. She hopes to complete her education at the University of Illinois and become a large animal vet.

Evans will be a summer employee of the Department of Agriculture. She will travel to about 30 county fairs and will be the official hostess of the Illinois State Fair in Springfield and the DuQuoin State Fair. As queen, Evans main duty is to emphasize the importance of agriculture and county fairs in Illinois.

Tessa Sargeant of Hancock County was named the first runner up, Audrey Moran of Clinton County was named second runner up, Elaina Kessler of Clay County was named third runner up, and Maci Kingren of Ford County was named fourth runner up.

"I'm a passionate girl," said Evans. "I love cows, my family, the Lord. I hope I can follow in Paige's (Van Dyke, her predecessor) footsteps and continue to show cattle while I'm queen."

When Evans isn't showing Red Angus cattle, you can find her boating, swimming, going to concerts, Bible studies, spending time with family or playing with her four dogs. She also is self-employed at Natalie's Pet Services. She's also an 11-year 4-H member and attended Routt Catholic High School.

"I'm the first state queen from Morgan County – I'm proud to represent Morgan County," she said. "I was so surprised when they called my number. I thought I did well, but I was honestly surprised.

## **Honor Friends of Illinois County Fairs**

This year's Friends of Illinois County Fairs were honored at the Saturday morning breakfast at the Convention.

Receiving the award were Sen. Tom Bennett of Gibson City, Ruth Blasingame of Boone County and Kate Boyer of Stephenson County.

Senator Tom Bennett was raised on a family farm. He has served as a high school and junior high science teacher. He then spent 30 years at State Farm Insurance managing he computer software development and training division. He served as State Representative for the 106th District for eight years and now serves parts of 13 counties in the 53rd Senate District.

Sen. Bennett has worked diligently with Agriculture and Education as two of his top priorities in the Illinois General Assembly. He has championed appropriations for county fairs across the state. He sponsored legislation supporting the hours earned from 4-H, FFA and agricultural education work be credited to the scholastic record of each member. In addition, legislation was passed to assist volunteer fire departments and police employees in their volunteer efforts.

Sen. Bennett has effectively served, not only his elected districts in the state of Illinois but the state in total. He has served with leadership skills, sets a high standard for a work ethic, is principled, shows the courage of his convictions and sets high standards for his colleagues to follow. Ruth became a Fair Board member in 2000 and has served for the last 24 years. She has a strong presence and offers her ideas and opinions freely, always looking out for what is best for the fair and fairgrounds.

It was just a few years after joining the Fair Board, in 2004, that Ruth took on the position of Ticket Office Chairperson. Under Ruth's direction, the Ticket Office operation has been streamlined into a welloiled machine. Ruth recently stepped down as Chairperson but has spent the last year mentoring the new Chairperson and continues to help in the office.

### 'Invest in Those Who Follow Our Footsteps'

Saturday morning breakfast speaker Aaron Alejandro, head of the Texas FFA Foundation, encouraged us to be grateful.

"When we appreciate, we elevate," he said.

We all have a purpose to invest in those who follow in our footsteps. Alejandro said he is the result of someone taking time to invest and believe in him. He grew up hearing his mother pray that God would provide food for them. He ended up living and working on a farm for troubled youth. Because the owner believed in him, he ended up showing cattle and graduated from college.

"What you do at your fair is create opportunities," said Alejandro. "We get kids there to give them a chance."

He acknowledged none of us saw Covid coming.

"Zig Ziglar would tell us to expect the best and prepare for the worst. Maximize what comes. Don't quit. Expect that disruption is coming – in life and at your fairs. Can you look at your fairs and expositions from a different perspective?"

He added, "Let's get back to the 3 Rs – not reading, writing and arithmetic, but respect, responsibility and resiliency. Not everybody gets a trophy but everybody can participate. What is it that you all do better than anyone else? The 3Rs. We teach responsibility – that animals get thirsty and have to have water even when it's cold, that if we don't do our job taking care of them, some-

thing dies. That's what agriculture does."

He encouraged fairs to look at technology as a tool to help draw in the 50 percent of the world's population that is under the age of 30.

"Fairs and expositions, what are you doing to compete for the minds of kids, for the values you promote? Get in the game and compete or surrender and lose."

He considers social media the #1 source of food information. A check of social media finds 73 percent of posts are about a cat or dog.

"What about cows or pigs?," says

Alejandro. "We're playing into the hands of the enemy. We need to talk about what it takes to care for an animal, not just show a picture of taking home a ribbon."

## **Update on State Government Affairs**

Hello IAAF Members! Here's a state government affairs update. Senate Bill 2876

Senate Bill 2876 mandates recycling and composting at "large event facilities" that are licensed for occupancy for 3,500 persons or more. We are watching the progress of this bill very closely. The intention of this bill is to cover very large facilities such as the United Center and ballparks in Chicago. However, we were concerned that it may impact county fairs so the sponsor has agreed to state for

The bill will be heard on Third Reading in the Senate during the week of April 8; if it passes, it will go to the House for consideration. We are making the same request of the House sponsor as statements of "legislative intent" during Third Readings on the House and Senate Floor have legal weight.

### Agriculture Advisory Committee

IAAF was asked by House Minority Leader Tony McCombie to participate in the first ever Women in Agriculture Advisory Committee. The first meeting was held in March and was organizational. Leader McCombie said that she formed the group in order to hear from female voices in the industry. The Advisory Committee will continue to meet during the year, and Leader McCombie hopes that the group will weigh in on legislation affecting agriculture issues in Illinois.

#### Update on New Rules Initiative with the Illinois Department of Agriculture

We continue to work with the Illinois Department of Agriculture to amend the Department's administrative rules to authorize fairs to submit their premium books to the Department via email instead of sending the printed book through the US mail to the Department. This change would reduce paper waste, and more importantly, costs to fairs in producing and printing the books. Some fairs are doing this already and it is acceptable to the Department. We are monitoring the JCAR (Joint Committee on Administrative Rules) process and will indicate IAAF's support of the change to the Committee.

## **Reimbursements Should Be End of May**

Happy Spring!

I hope everyone is doing well as you gear up for the 2024 Fair Season. I am looking forward to seeing what the 2024 fair season brings, and I wish you all great success!

I am glad to announce that the Premium Reports have been completed as of April 1st. My hope is that you will see your reimbursements no later than the end of May.

Reminder: the next important due date is June 1st for contracts. All fairs are required to submit a signed FY25 contract, and they are subject to a \$25/day late fee. The late fees will be deducted from your premium reimbursement or your F&E payment.

The contracts are available on the Department of Agriculture website. Please make sure you are submitting the correct type of contract for your type of fair, either F&E Reimbursement Agreement or Premium and Rehabilitation Reimbursement Agreement. Without a contract, I am unable to process your reimbursements for FY25.

Fairs participating in the Rehabilitation Fund must have their Rehab Reports postmarked by June 15th. Please make sure that you submit all supporting receipts. I will no longer be sending emails or making calls to fairs for missing supporting documents starting with this report and moving forward. A \$25 per day late fee will be deducted from the total rehabilitation claim if it is not postmarked by June 15th. Late reports must be postmarked no later than August 15 to qualify for rehabilitation funds.

Lastly, I'm excited to announce that I am working closely with IAAF and the State Fair office so your County Fairs will be represented on County Fair Day at the 2024 Illinois State Fair. More details will be announced in the near future.
