

Johnna Fulcher Named 2025 IAAF Queen

The Illinois Association of Agricultural Fairs held its 114th annual convention at the Crowne Plaza Hotel in Springfield, Illinois January 17-19, 2025.

One of the highlights of the annual event is the Miss Illinois County Fair Queen Pageant, held January

Johnna Fulcher, 20, of Geneseo was crowned the 67th Miss Illinois County Fair Queen. Johnna represented Henry County at the 114th Illinois Association of Agricultural Fairs Convention on Sunday. Johnna is the daughter of Margo and David Hohe. She is currently attending Blackhawk College and will graduate this spring with an associate degree in art. She plans to continue her education at Carl Sandburg College to pursue a degree in dental hygiene.

Fulcher will be a summer employee of the Department of Agriculture. She will travel to about 30 county fairs and will be the official hostess of the Illinois State Fair in Springfield and the DuQuoin State Fair in DuQuoin. As queen, Fulcher's main duty is to emphasize the importance of agriculture and county fairs to Illinois.

Delaney Epley of Christian County was named the first runner up, Claire Oliver of Sangamon County was named second runner up, Kaylee Ford of Western Illinois Fair was named third runner up, and Paris Van Dyke of Clay County was named fourth runner up.

Dressed in a sparkling purple gown, Fulcher described the moment her name was announced as

Honor Friends of Illinois County Fairs

Four individuals were selected for the 2025 Friends of Illinois Fairs award: Rhonda Mueller of Washington County, Craig Gebhardt of Carroll County, Deb White of Boone County and Susie Dvorak of Stephenson County.

Rhonda Mueller is a long-time fair board member who has served as President of the Washington County fair. She is known for her work to improve the fair including obtaining top rated music entertainment. Under her leadership, fair attendance has increased greatly. She also brought people together in the county by including Jaycees, Lions Club and the school district to participate in the fair. Her nominator said Rhonda is at the fair " 24/7 tackling any task needed big or small."

Craig Gebhardt started at the Carroll County Fair as a volunteer doing repairs and maintenance and cleaning up the grounds after a tornado. He later became a director for vendors. His nominator said Craig is skilled in recruiting businesses to organize extra entertainment and refreshments. Since then, Craig has served almost every office on the Carroll County fair board. He has passed his knowledge down to his grandchildren, convincing them to be in charge of "garbage management".

Deb White is a part-time employee of the Boone County Fair who works overtime every week. She is not only in charge of the office during the fair but all year long for offseason rentals. Her nominator said the Boone County fair would be a "mess without her."

Susie Dvorak has been a volunteer at the Stephenson County Fair for 37 years. She "lives and breathes" the county fair year-round. The fair was a favorite pastime of hers as a child and she now shares those same experiences with her grandchildren. She has served as codirector of the queen pageant and non-livestock superintendent. She also is successful at obtaining sponsorships, supporting superintendents and volunteers with her husband.

She currently serves as historian for the 170-year fair. Even her email reflects her love for the fair – it's susielovesthefair.



Recap of 2025 Annual IAAF Convention

What an amazing 2025 Illinois Association of Agricultural Fairs convention.

Some 73 queens competed for the title of 2025 Miss Illinois County Fair Queen with Johnna Fulcher of Henry County being named, four individuals were awarded Friends of Illinois County Fairs, some 80 vendors participated in the Trade Show, the Showcase had standing-room only crowds and two young students were named the Junior and Senior Talent Show winners.

Attendance was the highest in recent years.

Keynote speaker Mike Bradley shared with Saturday morning breakfast attendees how fairs can adapt to change in the future.

Be a big thinker. Daniel Burnam, who led the 1893 Chicago World's Fair, said "Make no little plans." He

was a big thinker.

Tell a new story. There are opportunities to tell a new story and educate fairgoers. He suggests exhibits on aquaponics, AI, insects, solar power, drones, seaweed or robots. All will be popular in the future.

Embrace technology. Everyone carries a phone. Use technology to stay in touch with your fairgoers and get them excited about coming to the fair and seeing what is there.

Dream big. He encouraged fair boards to ask fairgoers what they might be interested in and to try new exhibits and events.

On Friday evening, 7 bands performed to a standing-room only crowd at the Showcase, including the final premier presentation by Dirty Grass Soul band. While the bands played, attendees could sample Illinois wine and snacks, provid-

ed by Tom and Pam Schahrer.

Meanwhile, the Trade Show offered more than 80 booths for fairs to choose a carnival, magician, entertainer, motor sport, tractor pull, rodeo or concessionaire. It remains the very best place to bring live events to your fair.

Bill Jennings made an appointment to see me the first week I was named Bureau Chief of County Fairs and Horse Racing at the Illinois Department of Agriculture. He wanted to make sure this girl knew the basics of county fair funding and how important they were to the state's economy.

That meeting turned out to be one of many that Bill and I would have.

Several years later, after I had left the department to pursue my passion of working as a dietitian full time at Hy-Vee, it was Bill who asked me to consider the job of secretary-treasurer of the IAAF.

And it was Bill who always had my back – patiently explaining what county fairs needed or just being a friend to listen.

On New Year's Eve, 2024, Bill called from his hospital room and shared with me that he had been diagnosed with an inoperable cancer. We both cried and prayed God would touch him.

I, like, many of you, know we have lost a great friend of the IAAF. He was the first to share how important legislative matters were and how important it was that we all talk to our legislators. He was the emcee at County Fair day and the queen pageant banquet. At IAAF board meetings, he was a leader and voice of wisdom.

May we all strive to carry the torch he has passed on to us.

He was very active in County Fairs at the local and state level and was President of the Richland County Farm & Fair Association for the majority of his adult life, and past President of Illinois Association of Agricultural Fairs, and was currently serving on the Board of Directors as Southern Zone Director at Large.

Bill served as the Dairy Cattle Superintendent at the Springfield State Fair and the Duquoin State Fair.

Bill was an active member of the Masonic Lodge, the Shriners, and a Jester. He also supported the Shriners Children's Hospital.

Bill was an avid outdoorsman and enjoyed hunting, fishing, canoeing, and helping his sons with their gardening and landscaping endeavors. He took pleasure in golfing and served on the grounds and greens committee at the Richland Golf Club.

Bill played the role of mentor and father figure to many through the years. His influence will continue through the example he set.

Bill is survived by his wife, Barb Jennings of Olney; son, Greg Runyon and wife Cheryl of Olney; son, Pat Jennings and wife, Jess, of Olney; grandchildren, Owen Jennings, Ruby Jennings, and Evan Jennings; sister, Glenda Berry of Paris, IL; and nieces, Diane, Darcy, and Lori.

Hello IAAF Leaders! Hope is well. This is your spring 2025 state legislative affairs update. We are about halfway through the 2025 spring legislative session. The session is scheduled to adjourn on May 31, 2025.

Fair Funding for County Fairs

We continue to advocate for equitable funding for county fairs statewide.

There is good news: Governor Pritzker's proposed budget contains a small increase for county fairs within the rehabilitation budget line.

This line item contains funds to reimburse fairs for improvements made on the physical structures on fair property and other purposes. We are grateful to see this in the Governor's budget and have been working hard for the last few years to achieve it.

Please note that the Governor's budget is not the final budget document; it is only a blueprint or roadmap that must still go through the regular appropriations process in the legislature.

The key is to keep this small increase in the final budget that is sent to the Governor and we are working hard to do just that.

Spring Legislative Meet and Greet

The Illinois Association of Agricultural Fairs held the 2025 spring Legislative Meet and Greet on Tuesday, March 18 in Springfield.

Thank you to all that attended. We have partnered with the Illinois Grape Growers and Vintners Alliance for a number of years now. Next year, we will hold the event later in the session and will be sure to let you know the date.

Administrative Rules Changes

As you know, we have been working closely with the Illinois Department of Agriculture for some time to implement changes to the Illinois Administrative Rules that govern county fairs.

These changes are intended to update, simplify and streamline the requirements surrounding your interactions with the Department.

The Department is currently developing draft changes to remove all remaining references to notarization of documents by fairs and clarifying that fairs may send their premium books to the department electronically rather than by US mail.
